ITEP came out of collaboration between the NTA and the Institute of Behavioral Research at the Texas Christian University. ITEP builds on an inter-nationally evaluated model of service improvement. Following its successful implementation across London within Blenheim CDP services, this model of psychosocial interventions provides evidence based and easily evaluated tools for use by keyworkers across the drug treatment system and throughout the health and social care sector.
